Memberships | Kate O'Hara/Tara Wallace

- Current membership paid 217
- Another 88 confirmed, plus 24 probable goal is 350 will do a 'late' prize draw (Pik Fuels \$100), email to be sent out and posted on Facebook requesting / reminding people to pay by September 1<sup>st</sup>, 2022
- Budget for 2023 goal 350 = \$7,000, estimated expenses for 2023 membership materials

- Question for Livia where does the FOCA payment come from membership/general or communications or split equally? Looking to do the memo pad for 2023 packets, Kate will price it out.
- FOCA payment will pay for 300 this year. Will review at end of year and revise if significantly more than that. Kate will complete renewal form and send to Livia to send the cheque.

### Lake Steward | Natalie Corbin

- July Photo Contest on Facebook name draw for paid members, draw today (Winner Mike Gosse)
- Healthy Shorelines posting 08/14/2022, lake was turbulent and brought up e- coli from the bottom, historically not an issue for our lake. Opportunity to have folks come and host "love your lake" meeting. Natalie will be looking into it. Ministry post caused concern, but response was handled well laying out the facts.
- An email regarding people trespassing on shorelines was received. Facebook response to crown land and private land to be posted by Natalie for a few weeks, will include with the spring newsletter and on the website.
- Island View/boat launch potentially grant money to include a bathroom facility, Natalie will ask Cameron Montgomery from the North Algoma Township about the possible improvement of boat launch including warning signage.
- Water Levels windy year, checked Pikwakanagan dam and no issues with any leaks. Don Bishop has been posting great information about what is happening this year.
- Water Testing the Renfrew County health unit tests weekly for free (Island View, Red Pine, Hwy 60, Pikwakanagan), will continue as is due to if a problem is identified then they will research. The lake partner program also tests the lake, approval was given at the AGM. Link exists on the website for all information relating to water testing. 3.25 meters is the clarity of the lake currently.
- Hazard Markings busy summer, we have had some break off due to high winds but have been recovered and replaced. Will continue to grow the hazard marking program as required, may require some additional purchase of buoys/markers in 2023. Volunteers are making all efforts to retrieve chains and blocks when a buoy breaks off its mooring.
- Invasive Species in research mode, Matthew will be sending something out to the membership to identify where the issues are on the lake. Provide tips on how to deal with some of the issues. Focus on educating members and what they can do to participate.
