# **COMMITTEE REPORTS:**

Corporate Sponsorship Theresa Rasp

 All 44 sponsorship spots have been filled once again. Two past sponsors were not approached due to lack of payment last year (Golden Sands, Creekside

- Grill). CIBC pulled out at the very last minute.
- Three new sponsors have joined our corporate sponsors: Lakepoint Resort, Kokomish Cafe and Aki Wellness (who came on board at the very last minute)
- 31 of 42 sponsors have paid their annual fee (\$175 each): we are giving Andrea Rathwell (Century 21 Eady) a free sponsorship this year after her house fire last fall
- All signboards are now up to date (see other side)

### PRIZING

- Our Fish Fry which was held on May 19<sup>th</sup> at Red Pine Camp was a huge success the fact that we added walleye helped a lot giving people more value for their meal, our goals were to have a fun social event, to bring awareness to the walleye rehabilitation plan and to raise funds for our rehabilitation program, all our goals were met. Having the attendance and help from the NAW Fire Department with the fire trucks as an attraction for the kids, the music by Casey and Company, Whitewater beer garden, and of course the very fun and successful kids fishing derby made for an amazing day. We had a few small organization issues that will be addressed next year, thank you to everyone that attended, the volunteers and especially to Brian and Diana Yourth who did an over the top job of organizing things.
- It was a huge social family event.
- 35 Children registered for fish derby...
- We sold 220 meal ticked our total sales for the day \$6,490.00 which gave us a profit of \$3,365.34.
- The progress of the rehabilitation plan continues more slowly then we want, bureaucracy from MNRF and AOP has inputted to this however we are making up ground, we had a video call with the Minister of Natural Resources on May 16 that went well and we brought to his attention the challenges we have been having and he committed to help. We are hopeful that we still have a chance

to implement later in July but if we do not we will be in place to do so in the spring.
